- City Council Workshop was called to order by Mayor Foster at 7:00 p.m.

- V. Citizen Participation

Don Poenisch stated his opinion that the City and residents should help their neighbors not make things harder. The City has current, valid and effective ordinances.

Bruce Thauburn stated everyone is bound by rules, in his opinion the proposed ordinances revisions are going too fast. The comprehensive master plan should be revised before any ordinances are revised. The proposed ordinances are comparable to the old ordinances and the revisions should be done slowly.

Charlotte Lawrence stated she was concerned about statements made by P&Z members. Things have changes since Hurricane Katrina and we need to stay up to date.

Marci Counter agreed we are now in post Katrina; there must be guidance and laws for our own safety. The City needs to move with the times.

Jim Isbell clarified his remarks he made referring to his property taxes and the response of other citizens. He is unclear how the ordinances have anything to do with FEMA. He also stated his opinion against sections in the proposed ordinances.

Mayor Foster explained the ordinances being reviewed are from 1992 and the laws have changed and are not longer in existence. The ordinances need to reflect the changes in the laws. In the past Council Meetings it has been made clear that updating needed to be done, however, nothing has been revised to reflect the changes in laws and regulations.

Item A: Discuss Ordinance Relating to Regulation of Litter, Weeds, Rubbish, Carrion, Filth and Care of Premises

Comments were received from the audience.

Alderman Ehmann stated she has compared the proposed ordinance with the current one, they say much the same thing. Alderman Ehmann, Garbutt and Gillespie stated their agreement with using the current ordinance with changes to up date it. Bruce Thauburn asked for a natural vegetation clause be added to the changes. Discussion occurred concerning right of way requirements. A request for fee increase was made

Item B: Discuss Ordinance Relating to Regulation of Abandoned and Junk Vehicles and Other Abandoned Property

Comments were received from the audience.
