CITY COUNCIL MEETING
March 24, 2009

- I.** City Council Meeting was called to order by Mayor Gillespie at 7:00 p.m.
- II.** Silent prayer was observed.
- III.** Mayor Gillespie led the Pledge of Allegiance.
- IV.** Roll Call: Present were: Mayor Gillespie, Alderman Marroquin, Garbutt, Ehmann, and Robbins. Alderman Morgan was absent.
- V.** Minutes of Previous City Council Meetings of March 3 and 12, 2009 were approved as written.
