

**CITY OF INGLESIDE ON THE BAY  
CITY COUNCIL PUBLIC HEARING

- I. City Council Public Hearing was called to order by Mayor Gillespie at 7:00 p.m.
- II. Roll Call: Present were: Mayor Gillespie, Alderman Merrick, Ehmann, Morgan and Robbins. Alderman Marroquin was absent.

**III. Business: Discussion**

Item A: Discuss and receive input concerning a Dangerous Building located at Block 124 Lot 11, 609 Tanglewood

No persons with any interest in the property were present at this hearing.

Jimmy Durham explained the condition of the structures located at 609 Tanglewood. The buildings have become more deteriorated over the past three years. The garage is in very bad shape, the house has wholes in the roof and animals have been inside the structures. He is not able to enter the house for a more thorough inspection. Hal George stated a court order can be issued to enter the structures. The Public Hearing was published in the Ingleside Index in order to notify any heirs of the meeting. Input from citizens indicated a concern for the any remaining buildings being within City codes.


Item B: Approve/Disapprove Ordinance requiring a permit to film by film crews within the City using the City as a set location.


**X.** Mayor Gillespie adjourned the meeting at 7:36 p.m.
