- I. City Council Meeting was called to order by Mayor Gillespie at 7:00 p.m.
- II. Alderman Ehmann gave the invocation.
- III. Mayor Gillespie led the Pledge of Allegiance.
- IV. Roll Call: Present were: Mayor Gillespie, Alderman Marroquin, Merrick, Ehmann, and Robbins. Alderman Morgan was absent.
  
- V. Minutes of Previous City Council Meeting and Workshop of June 21, 2011 were approved as written.
  
- VI. Citizen Participation
