Item B: A variance request at 471 Woodhaven was discussed and approved for a 1ft. increase on roof height. Which is one-foot above FEMA regulations and Ingleside on the Bay Building Ordinance, putting the maximum height at 34 feet from street level. Drainage issues will be addressed as building progresses. The motion was made by Alderman Daley, seconded by Alderman Nyberg and all present approved.

No. 140A and the east/ southeast 42.67 feet of block No. 141A, Ingleside townsite was approved.

Item D: There was an update on roadwork being done on Woodhaven. The County Commissioner reported that the base of the road would be raised by 6 inches or more and the curve of the road will be raised to address the drainage issues.
