Ordinance No. 1992-10

An Ordinance of the City of Ingleside On The Bay, Texas, Citing the need for law and order in the city, creating a department of Public Safety, stating the intent to file application for a department Identification number with the Texas Commission on Law Enforcement as mandated in Section 341.022 of the Texas Local Government Code, placing the department of Public Safety under the jurisdiction of the office of the City Marshal and setting penalties for violations of this Ordinance.

- WHEREAS, there is a need for law and order in the City of Ingleside On The Bay, Texas and
- WHEREAS, there must be an agency created to preform such duties to bring the City into compliance with Section 341.022 of the Texas Local Government Code, and
- WHEREAS, An application must be filed for an Identification Number for said agency with the Texas Commission on Law Enforcement, now

THEREFORE, Be It Ordained:

SECTION I:

- A. By order of the City Council a new department for the City of Ingleside On The Bay, Texas is now created. The Department of Public Safety is now and will be a department of the City of Ingleside On The Bay, Texas.
- B. The department of Public Safety shall be under the jurisdiction of the office of the City Marshal, as mandated by Section 341.022 of the Texas Local Government Code.
- C. Immediately following passage of this Ordinance, a copy of same along with a complete application form for an Identification Number for the department of Public Safety of the City of Ingleside On The Bay, Texas shall be mailed to the Texas Commission on Law Enforcement.

SECTION II:

- A. The department of Public Safety shall enforce the laws of the State of Texas, the County of San Patricio and the Ordinances of this City that are applicable to the department as set forth in the Texas Local Government Code for Class B cities.
- B. The Marshal may, with the approval of the City Council, appoint deputies and/or personnel, as the need for additional personnel may arise, to insure the efficient performance of the department.

SECTION III:

A. Violation of any law as cited in this Ordinance shall constitute a misdemeanor, punishable by a fine, upon conviction in Municipal Court, not to exceed two hundred dollars (\$200.00).
