ORDINANCE NO. 1992-18

ADOPTING THE BUDGET FOR THE NEXT FISCAL YEAR

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF INGLESIDE ON THE BAY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1992 AND ENDING SEPTEMBER 30, 1993, ADOPTING THE ANNUAL BUDGET OF THE CITY OF INGLESIDE ON THE BAY, SAN PATRICIO COUNTY, TEXAS FOR THE 1992-1993 FISCAL YEAR.
