## ADOPTING THE BUDGET FOR THE NEXT FISCAL YEAR

SECTION I. That the appropriation for the fiscal year beginning October 1, 1996 and ending September 30, 1997, for the support of the general government of the City of Ingleside on the Bay, Texas, be fixed and determined for said terms in accordance with the expenditures shown in the City's fiscal year 1996-1997 budget, a copy of which is appended hereto as Exhibit A.

SECTION 2. That the budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's budget for the fiscal year beginning October 1, 1996 and ending September 30, 1997.
