

**AN ORDINANCE CEDING EXCLUSIVE ORIGINAL JURISDICTION
OVER ELECTRICAL UTILITY RATES, OPERATIONS AND SERVICES
TO THE PUBLIC UTILITY COMMISSION OF TEXAS;
PROVIDING FOR PUBLICATION**

WHEREAS, Ingleside on the Bay by Franchise authorizes the provision of electrical service by Central Power and Light Company;

WHEREAS, under the Public Utility Regulatory Act, Ingleside on the Bay regulates all local utility service until the Public Utility Commission of Texas assumes jurisdiction over local utility service;

WHEREAS, a municipality's decision are appealable to the Public Utility Commission of Texas;

WHEREAS, Section 33.002, Utilities Code, allows a municipality to elect to have the Public Utility Commission of Texas exercise exclusive original jurisdiction over electrical utility rates, operations and services;

WHEREAS, the Public Utility Commission of Texas has the experience, expertise and resources to exercise such jurisdiction.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF INGLESIDE ON THE BAY, TEXAS THAT:

Section 1. Ingleside on the Bay elects to have the Public Utility Commission of Texas exercise exclusive original jurisdiction over electrical utility rates, operations and services and hereby cedes its exclusive original jurisdiction over electrical utility rates, operations and services to the Public Utility Commission of Texas pursuant to Section 33.002, Utilities Code.

Section 2. This Ordinance shall become effective upon the publication of ~~the caption~~ hereof in the official newspaper of the City.

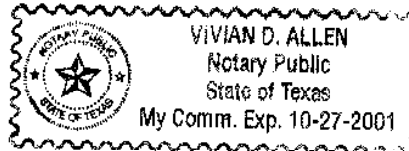
