AN ORDINANCE DECLARING EACH UNOPPOSED CANDIDATE IN  
THE MAY 14, 2011 ELECTION ELECTED TO OFFICE WITHOUT  
REQUIREMENT OF VOTE


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE ON  
THE BAY, TEXAS:

**Section 1.** The City Council has received a certification of unopposed status from the City Secretary certifying that Jo Ann Ehmann and Hector Marroquin as Council Members on the City Council and Thomas Merrick as the City Treasurer and a Candidate for the Election are unopposed for the three vacancies, only one candidate's name is to be placed on the ballot for each office and no candidate's name is to be placed on a list of write-in candidates. The certification is attached hereto as Exhibit 1. The City Council pursuant to Texas Election Code, Chapter II, Subchapter C. Section 2.051, et seq, orders and declares Jo Ann Ehmann, Hector Marroquin and Thomas Merrick as unopposed candidates are elected to the office of City Council.


**Section 2.** A certificate of election shall be issued to each such candidate in the same manner as provided for a candidate elected at the election.

This letter is to certify that for the May 14, 2011 City Election:

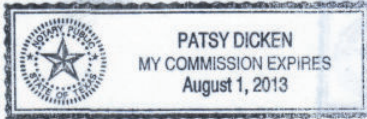
