

ORDINANCE NO. 2013-07

ADOPTING THE BUDGET FOR THE NEXT FISCAL YEAR

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF INGLESIDE ON THE BAY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2013 AND ENDING SEPTEMBER 30, 2014 ADOPTING THE ANNUAL BUDGET OF THE CITY OF INGLESIDE ON THE BAY, SAN PATRICIO COUNTY, TEXAS FOR THE 2013/2014 YEAR.

WHEREAS, the budget, appended here as Exhibit A, for the fiscal year beginning October 1, 2013 and ending September 30, 2014 was duly presented to the City Council by the Mayor and a public hearing was ordered by the City Council and a public notice of said hearing was caused to be given by the City Council and said notice was published in the *Ingleside Index* and said public hearing was held according to said notice, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE ON THE BAY:


SECTION I. That the appropriation for the fiscal year beginning October 1, 2013 and ending September 30, 2014, for the support of the general government of the City of Ingleside on the Bay, Texas, be fixed and determined for said terms in accordance with the expenditures shown in the City's fiscal year 2013/2014 budget, a copy of which is appended hereto as Exhibit A.

SECTION II. That the budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's budget for the fiscal year beginning October 1, 2013 and ending September 30, 2014



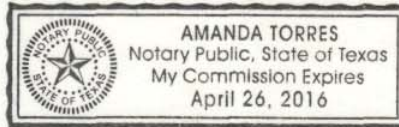
